- All applications must be submitted on the official forms available from the Award Manager or the 10-10 web site. A computer printout with the same information may be submitted in lieu of the official application.
- Entries for each application must be listed in ascending order of 10-10 numbers.
- A 10-10 number may be used only once in a bar award program. Only **5** errors are allowed on a bar application.
- QSL card confirmation is **NOT** required for the BAR award program.
- 10-10 award general rules and requirements are applicable.
