Election Results

Tom Henderson, K4CIH #33233, and Chuck Imsande, W6YLJ #19636, both ran unopposed for the offices of President and Vice President respectively. The Board of Directors, at the recent Board meeting in St. Louis, MO, on July 23rd., declared that both Tom and Chuck be elected to their respective offices with their terms commencing January 1, 1995, as is the case with all others who were elected.

Certificates Replace Plaques

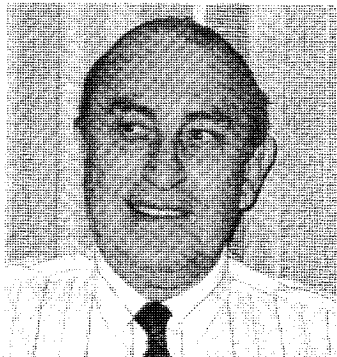

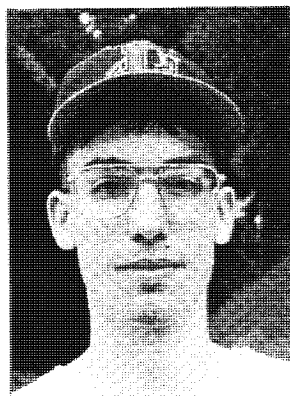

An-Ten-Ten-nas

In each issue of the News, we shall try to clarify a significant cluster of ideas used in antenna work. Our object is to help you make the best decisions about the antennas you buy or build with out imposing our own prejudices on you. The more you understand, the better your choices will be.

No. 4: Antennas and Low Sun Spot Counts

As much as we hate to admit it, 10 meter conditions have been rotten. Instead of sunrise to sunset contacts across the ponds east to west, we hear only some weak north-south dx and a few weaker U.S. stations (from the U.S. perspective, of course). Occasionally during the day, the band will open a little for east-west skip. So, what kind of antenna is best for these conditions?

The answer depends on another big question: what kind of operating do you want to do? Let's look at three main answers: a. I want to work my local chapter and friends. b. I want to work those super weak signals, c. I'll take whatever I can get whenever I can get it. Each answer suggests some different antennas.

Local: Local chapters of 10-10 and other area communications are still wide open on 10 meters. That is because they are primarily point-to-point. (Note: we habitually call this ground wave, but usually it is not. Ground waves peter out on 10 very quickly. Just as on VHF, our elevated antennas look directly at each other: that is point-to-point.) Since most established hams have horizontal antennas, a vertical can be a disadvantage unless everyone is very close. Up to half the signal gets lost due to cross polarization.

The basic local antenna is still the dipole. If possible, make it rotatable, even if by hand, and as high as you can get it. Aluminum rod or tubing about 16' long, fed with coax at the center on a single mast works quite well.

If you live on the fringe of your local group, consider a simple 2-element beam, either fixed to point at the group or rotatable. The commercial HF5B is a typical compact multi-band design with a

wide forward lobe (to catch everybody in the group) and modest front-to-back ratio. Since there is little trouble from QRM, the modest F-B ratio actually lets you hear someone off the back of the beam better than a station with a large beam designed to suppress virtually everything off the backside.

You can build a 2-element Yagi from supply store parts. If you are into building antennas, you might want to consider other designs for the fun of it.

The Moxon rectangle, a wire beam, has about the broadest forward lobe and excellent rear suppression, but a little less gain. The X-beam is a bit tricky to set up, but is quite compact (a square under 10' on a side). Linear loaded Yagis can cut the element length from 16 to 12 feet. And the ZL-special can be built from 300-ohm parallel line (TV ribbon) on a light frame or suspended at its ends and fed with coax. If any readers are interested in these designs, I'll present some details in future columns. Meanwhile, look at any of the antenna books to gather some basic ideas.

Weak Signal Work: Much of the weak signal work done on 10 during sun spot lows is via backscatter, that is, by bouncing signals off the edge of the ionized layer, as weak as it is. That same layer, weakly hovering over the tropics, is responsible for the north-south skip that appears while the east-west path is too weak to support communications. So many 10-10ers point their beams south (or, if in the southern hemisphere, north) and listen carefully.

For the best results on backscatter and very weak skip, an antenna with the maximum forward gain is best. Again, the front-to-back ratio is unimportant, since there is no QRM. (However, few hams want the antenna just for sun spot lows, so they do pay attention to front-to-back ratio.) A long Yagi is perhaps best among the aluminum antennas. If designs are optimized, the gain depends on the boom length, so the longer the better (if you can support it).

Some wire antennas are capable of excellent gain, even if bidirectional. The extended double Zepp is over twice as long as a dipole, but narrows the beam width and has gain over the dipole. Dipoles (that is, antennas fed in the center) of a full wavelength can be set about a quarter wavelength apart and fed 180 degrees out of phase for additional gain. So too can EDZ dipoles (1 1/4 wavelengths long). These antennas usually (but not always) require parallel feeders and an antenna tuner. But the materials are cheap. Run the wires east to west for north and south lobes. For sun spot backscatter and transequatorial skip

a fixed wire beam is not a bad choice. Again, if there is any reader interest, I'll provide more details in future columns.

Anything I Can Get: For general operation, use what you have and be patient. First, learn the band's habits. When do the openings occur? In what directions? How long do they last? Then plan your operating accordingly. Second, be sure your receiver is quiet so you can hear what there is. Early synthesized rigs are noisier internally than the preceding generation of crystal-mixing rigs. Direct-digital synthesis in today's rigs still leaves some noise on 10. That's why Ten-Tec offers both synthesized and crystal-mixing rigs and why some hams hang onto their old Drakes, TS-520s, and so on. The antenna is part of a system, not a solution to everything.

Third, plan your antenna for long term use, not just for the present lull in apparent activity. If you have room for antennas and like to build, have fun with experimental designs. But also plan the main system for the day when the sun spots return. (And, although we 10-10ers hate to admit it, that planning may involve operation on other bands, too.)

Finally, use your antennal. Very often a band is only as dead as the operators sitting around complaining about it. Listen to 10 on contest weekends to discover its true potential. Contesters (inadvertently) QRM each other on a supposedly dead band. Vertical or horizontal, your antenna will do you no good if everyone thinks the band is dead without checking. Find net frequencies, especially the daily 10-10 nets, and listen. If you cannot hear the NCS, request a relay check-in to find out if anyone is in the right place to hear you. Try some "CQs" near frequencies that used to be active. Make your presence known, of course, within the boundaries of good operating practice. 10 meters is more open than you think.

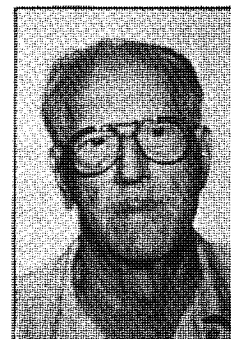

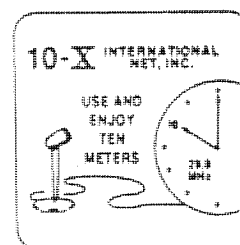

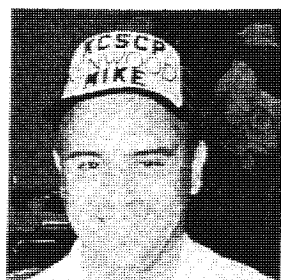

The most significant events this past quarter was the modest activity during the Summer QSO Party where we had little DX activity. Conditions during the QSO Party were better than last summer but since then band conditions have gotten worst and will not get better until late October! I only worked 24 DX stations in the QSO Party but I had over 400 stateside contacts. **VE7ACM** Garry #30939, who is in the Vancouver area, wrote me during the QSO Party and said he had 17 contacts when he started the 2nd day. Garry said he made 3 contacts during the Spring CW QSO Party.

I have only been operating mostly on the weekends collecting information to put together this Fall article. I have noticed the number of DX contacts has been much lower this past quarter. For those in the US, look for better conditions about the time of the CQ WW DX contest in late October and expect the DX season to close about mid March 95. The next Solar cycle will begin in early 1996 so expect improved DX conditions in the winter of 1996!

The count of **10-10 Countries** is still 269, as no new activity has been reported this past quarter. I would like to get updates from anyone chasing DX. If ou can give me a list of DX calls and numbers you have worked, I will compare these with my list to keep the 10-10 Countries list up to date. Thanks to **K9EHP** Bill #2847 for his DX list. **K8DHK** Carol, the DX Manager, told me that the number of new DX members was less than 10 this past quarter! We may have the opportunity to see the first 10-10 activity from **VU4 Andaman Islands**. In October, **VU2SMN** Suhas #47460 plans to operate from the Andaman Islands.

Propagation: Solar flux will average **74-94** in the Fall of 1994 which is a lower average than last year. Solar flare activity will produce disturbances, drive up the A & K and result in no skip. Expect flux dips to 68, high **A** indexes greater than 20 and the **K** index greater than 5, will occur **30%** of the time. DX propagation will change to East & West paths into Europe, Asia & Africa as the fall season opens in the US. Expect sporadic E Layer

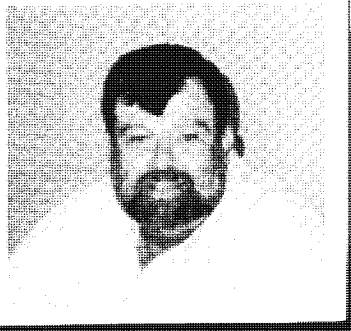

At the invitation of the Board, Treasurer Keith Schlottman, K17RK, was also in attendance, but without vote. Absent was Director Elaine Nickoloff, N8CBE, due to the serious illness of her mother. The Board observed a moment of silence in memory of our silent keys. The Board approved the agenda and orders of the day, which are appended as a part of this record. The Minutes of the September, 1993, meeting of the Board were approved without dissent. (Agenda 1-5)

The Board heard reports from the Officers and Committees. President Lefcourt thanked Vice-President Sullivan for his leadership during the past year during which the President suffered ill-health. 10-10 appears to be on a good track with the committee system generally working well and with inter-committee cooperation. The President hoped that this system would expand its work and its intercommittee communication and cooperation in coming years. The President thanked the Secretary and Director Henderson for the many hours of work going into the production of the *Operations Manual*. During this, the President's last meeting of the Board, and in the future, his first thought would be what is best for 10-10. (6)

Vice-President Sullivan summarized his written report, noting that at the request of the President, he had filled two vacancies on the Board with Board approval, moderated the 10-10 Forum at Dayton, worked with the Membership Committee to reassign the functions of three Area Managers and the Records Manager, and prereviewed the *Operations Manual* with suggestions for improvements and additions. In addition, with the approval of the Board by unanimous mail vote, the call and 10-10 number of N7KRS was removed from all records of 10-10 because there is good reason to believe that it is not a valid call. Without dissent, the Board accepted the Vice-President's report. (7)

Secretary Cebik summarized his written report, noting the preparation of Minutes for September, 1993, the amendment of the Bylaws; the development of an archival file with key original documents, the construction of a policy for filling vacancies on the Board as directed by the Board in 1993, the drafting (with Director Henderson) of an *Operations Manual of Policies and Procedures of 10-10 International Net*, the verification of a petition for candidacy to the Board in the 1994 election, the conduct of several pollings of the Board, the organization of ongoing files for the office of Secretary, and the preparation of a policy proposal to regularize mail and phone business conducted by the Board. Without dissent, the Board accepted the Secretary's report. (8)

Treasurer Schlottman presented his report with extensive documentation. The year from April, 1993, through March, 1994, ended with a net income of \$1,827.93, after expenses of \$62,728.05. The total assets of 10-10 as of May 31, 1994, were \$184,896.95. The Treasurer proposed a budget for April, 1994, through March, 1995, consisting of an anticipated income and expenses of \$56,700. The budget reflects less income from renewals due to the sunspot cycle but savings in various operating categories. Treasurer Schlottman noted fluctuations in the quarterly balances due to predictable surges in both income and block expenses, but characterized the cash picture of 10-10 as solid. On the motion of Director Hagan, with second by Matson, the Board unanimously accepted the Treasurer's report and budget. Director Imsande moved, with second by Henderson, that the Treasurer

provide all members of the Board of Directors with annotated quarterly reports as they become available after the close of a fiscal quarter, and that this duty be added to the duties of the Treasurer enumerated on the *Operations Manual*. The motion carried unanimously. (9)

Director Barnes summarized the written report of the Communications Committee, noting the completion of the initial draft of the *Operations Manual*, the completion of the new edition of the *Official Ten-Ten Awards Guide* with no change in cost, the application to the Dayton Hamvention for a booth, the handling of member complaints with either corrective actions or referrals to other committees for corrective action, and assistance to various hamfests to take renewals of membership and distribute information to encourage new memberships. On motion of Director Hagan, with second by Matson, the Board unanimously accepted the Communications Committee report. (10)

On behalf of the Finance Committee, Director Imsande presented a written report of the Data Manager. In addition to extensive information of the distribution of membership and anticipated membership renewal data, the report also demonstrated the savings to 10-10 in data services. In addition, an "address correction requested" addition introduced into the newsletter labels resulted in almost 350 address corrections at a cost of \$0.35 each. Director Imsande moved, with second by Barnes, that the Membership Committee establish with the Data Manager a procedure for following up on the post card renewal reminder currently used in order to encourage renewal of 10-10 membership. The motion carried unanimously. Subsequently, Director Henderson moved, with Redwine seconding, that the Data Manager's report be accepted as presented by Director Imsande, and the motion carried unanimously.

Director Imsande continued to report for the Finance Committee with written reports from Morrie Goldman, W6EHM, who serves as 10-10 Historian; as Trustee of W6OI, the 10-10 Club Station; and as Scholarship Manager. The Historian reported that he now has bound copies of *10-10 News* through 1993 as an aid to researching historical data for any 10-10 member. The Trustee reported on discussions with Director Matson concerning the development of a universal W6OI QSL card for use at Special events. The Scholarship Manager reported a total of \$1,630 in donations to the scholarship fund from 24 members or families through June 13, 1994. At present, recipients of the two \$750 10-10 scholarships have not been announced by FAR, but will appear in the next issue of *10-10 News*. On motion of Imsande, with second by Hagan, the Board unanimously voted to provide certificates of appreciation to donors to the Scholarship Fund. On motion from Director Barnes, with second by Ellison, the reports of W6EHM were accepted without dissent. (11)

Director Williams noted that there would be no report from the Membership Committee due to the absence of Director Nickoloff. He appealed in general that all committee Chairs effect good communications with their members in order to ensure full participation in the work and smooth transitions of effort whenever committee responsibilities had to be shifted from one member to another.

Director Ellison presented the written report of the Operations Committee, noting the appointment in September, 1993 of Rex Holford, KF0YF, as WPX Award Manager and Lonnie Butler, N9OSN, as 1000+ Bar Manager. Subsequently, Manager Butler had to resign this position and his post as Wednesday 28,380 kHz NCS.

Net Manager Greene has been notified and is searching for a replacement, in addition to handling the potential reassignment of Tuesday 28,800 kHz NCS position. Tom Henderson, K4CIH, has temporarily assumed the position as 1000+ Bar Manager while a permanent Award Manager is sought. The Operations Committee noted with sadness the loss of Peggy Pinnell, G4MAE, from the

Board and the Committee due to ill health, and the appointment of Ed Redwine, K5ERJ, as a replacement. In addition, Harry Syring, WB1FTQ, Contest Manager has been succeeded by Harry Arsenault, K1PLR. On motion of Director Williams, with second by Matson, the Board unanimously accepted the report of the Operations Committee. (13)

Director Miller reported for the Planning Committee, noting the development of the agenda for the present Board meeting and plans for the 1995 Board meeting and National 10-10 Convention to be held June 16-17, 1995, in Tuscaloosa, Alabama. On motion of Director Barnes, with second by Redwine, the Board unanimously accepted the plan for a National Convention in Tuscaloosa, June 16-17, 1995, with the Board meeting on the 16th and the convention proper on the 17th. Further information to be provided by Director Henderson, was deferred to unite it with consideration of the 1996 Board meeting and the 1997 National convention in items 16 and 17 on the agenda. (14)

Before turning to the Orders of the Day, President Lefcourt suspended the agenda in order to move, with Director Matson seconding, that the unopposed candidates for President, Tom Henderson, K4CIH, and for Vice-President, Chuck Imsande, W6YLJ, who are not on the printed ballot, be declared by the Board elected to their respective offices with terms commencing January 1, 1995; and in addition, that in all future elections, all duly nominated candidates be listed on the ballot, even if unopposed. The motion carried unanimously.

The Board adjourned for lunch at 12:00 and reconvened at 1:00 P.M., with all previously noted members present.

Returning to the Agenda and the Orders of the Day, Secretary Cebik presented the draft *Operations Manual of Policies and Procedures of 10-10 International Net* (hereinafter, *Ops Manual*). He moved, with second by Henderson, that the Board should accept the *Operations Manual of Policies and Procedures of 10-10 International Net, Inc.* as the compilation of policies, procedures, practices, and activities of 10-10; that the Board affirms approval for each policy, procedures, practice, and activity contained in the *Manual*, subject to revision, amendment, or expansion at future meetings of the Board in accord with Board procedures; that following each annual meeting of the Board of Directors, the Secretary shall prepare revisions of this *Manual* occasioned by actions of the Board. He or she shall distribute revised sections of the *Manual* to each member of the Board, including newly elected members of the Board in election years. The *Manual* will be maintained both as a document and as a set of computer files for ease of reference and revision. The Board unanimously approved the motion. (15-1)

Secretary Cebik moved, with second by Imsande, that a new section be added to the *Ops Manual* to regularize business conducted by the Board and to provide a permanent record of such business, the section to read as follows: "3.4.3.1 Business conducted by mail or phone between meeting of the Board of Directors shall be conducted in accord with the following guidelines: 1. The appointment of Net Officials to fill volunteer posts by appropriate officers and Committees of the Board shall be reported in writing within the Committee's next report to the Board. Acceptance by the Board of the Committee's written report shall constitute ratification of the appointment. Similarly, changes of procedure for any activity overseen by an officer or Committee of the Board shall also be reported in writing in the Committee's report to the Board, and acceptance of the report shall constitute approval of the change, with the direction that it be entered into the *Operations Manual* in the appropriate section. 2. Actions by the Board as a whole which constitute a change or revision of current policy, procedure, practice, or activity of 10-10, when instituted by mail or phone between meetings of the Board, shall, if approved, be considered effective but provisional until the next Board meeting. The Officer or Director taking the lead role in such a change shall keep the following record

for submission to the Board at the next meeting: a. The exact wording of the proposed change to policy, procedure, practice, or activity. b. The exact wording of current policy, procedure, practice, or activity, as provided in the current *Operations Manual*, along with the section number in which the matter is addressed. If the proposal is new, the record should show the section of the *Manual* to be created or expanded. c. The vote of the Board by name of Officer or Director that resulted in action upon the proposal. d. The date of the original proposal, the date of affirmative vote, and the date that the proposal becomes effective. 3. Each action approved by the Board and its requisite detail as specified above shall be entered into the Minutes of the Meeting as a special section of the report of the Officer or the Committee taking the lead role with respect to the proposal. Acceptance of the report of the Officer or the Director shall constitute approval of the action, causing it to be a permanent part of 10-10 policies, procedures, practices, and activities. If appropriate, it will then be entered into the *Operations Manual* in a suitable section. 4. Nothing in these guidelines shall prevent the Board from reconsidering a mail or phone action later in the meeting, and the final disposition of the matter will depend upon the whole of the Minutes of the Meeting." After discussion, the motion carried unanimously. (15-2)

After initial discussion of sections of the *Ops Manual* referring to responsibility for updating the document and basic distribution of the document, Director Imsande withdrew motions relating to those items. President Lefcourt then moved, with second by Director Williams that full members may receive a copy of the *Ops Manual*, without historical documents, upon request and a payment of \$8.50 post paid. The motion carried unanimously. (15-3-1, a-c)

Director Matson proposed revisions to *Ops Manual* in several areas. First, he proposed that the Board decide whether to pay or not to pay certain expenses associated with travel to Board meetings. After discussion, Director Matson moved that under section 13.4.2, Specific Expenses Eligible for Reimbursement, entry 5., Airline Fares, be renamed "Air Travel," and that in addition to airline fare (when reimbursable), the cost of parking for up to 72 hours at the originating airport and ground transportation shall be paid. Mileage from home to and from the originating airport at a current rate of \$0.29 per mile, plus tolls, shall be reimbursable. After second by Secretary Cebik and extensive discussion, the motion carried with all voting aye, except Henderson, who voted nay. (15-3-2a)

As a result of an original proposal by Director Matson and discussions with Director Imsande and Secretary Cebik, the following data regarding the 10-10 Club station was proposed for addition to the *Ops Manual*. Because the text was complex and not available in its entirety prior to the meeting, its acceptance upon motion by Secretary Cebik and second by Director Barnes is considered by the unanimous vote of the Board to be in principle, subject to circulation and review of these minutes, with the possibility of corrections, deletions, and additions left open as a matter for further mail business by the Board. The current section 1.2 and subsections of the *Ops Manual* shall be renumbered section 1.3 and subsections, and a new section 1.2 created to read as follows: "1.2 10-10 Club Station: 10-10 maintains the station call W6OI, 10-10 #109, as the official 10-10 club station under the direction of a station trustee (currently W6EHM). W6OI is active at special events. Any full member or chapter wishing to activate W6OI at a special event must obtain permission from the trustee who will evaluate the appropriateness of the use of W6OI at the event and, if approved, name one or more full members whose licenses permit operation on the entire 10 meter band as control operators. Control operators will be responsible for ensuring that the station is operated in accord with FCC regulations and the highest standards of operation so as to reflect well upon 10-10 and to maintain suitable log records. Upon request by the approved special event, 10-10 will provide QSL cards for W6OI. Filling out and mailing the QSL cards will be the responsibility of the special event. Excepting the cost of the QSL cards themselves, all expenses

connected with the activation of W6OI will be borne by the special event. Other expenses of operating and maintaining W6OI--for example, at 10-10 national conventions--and for QSL cards will be paid by 10-10 upon approval of the Finance Committee." To the list of Net Officials, before the list of Area Managers, insert "Station Trustee: W6OI Morrie Goldman, W6EHM." Renumber section 5.8 and subsections as 5.9 and subsections, adding a new section as follows: "5.8 Station Trustee, W6OI: The Station Trustee is responsible for overseeing the continuing activation of W6OI, the 10-10 Club Station, and reports to the Communications Committee. The Trustee's duties include the following: 1. To ensure that the club station license is renewed so that it is always current; 2. To receive and approve (if appropriate) requests of special events to activate W6OI, ensuring a. that the event is one appropriate for W6OI activation, b. that one or more control operators are named who are full members and whose licenses permit operation on the entire 10 meter band, c. that, upon request, QSL cards are supplied to the special event for confirming contacts, d. that a suitable log and other records are maintained, and e. that the station is operated in accord with FCC regulations and the highest operating standards so as to reflect well upon 10-10; 3. To maintain a supply of QSL cards for use by W6OI and special events; 4. To obtain approval of the finance Committee for expenses connected with the maintenance and operation of W6OI, including the cost of printing QSLs, but excluding costs incurred by special events operations; 5. To receive approval of the 10-10 Board of Directors for the QSL design, since it reflects upon 10-10; and 6. To report annually to the Board of Directors through the Communications Committee all activities of W6OI during the past year." (15-3-2b)

Director Miller added several comments to the discussion of the *Ops Manual*. He noted that although there is some sentiment that the words "to handle traffic" be removed from the statement of 10-10 purpose, the common practice of asking whether there is emergency traffic on nets suffices to warrant their retention. Director Miller also objected to any current dissemination of the historical view that without sufficient activity 10 meters might be lost to amateur radio assignment. To the matter of whether the President or other officer serving on a Committee of the Board may be counted toward a quorum or have a vote other than case of a tie, considerable discussion by the Board resulted in no definitive action. On the matter of whether donations ought to be received by the 10-10 general fund or encouraged for donation to the scholarship fund, it was the will of the Board without vote that people wishing to make donations to 10-10 should be encouraged to donate to the Scholarship Fund, but that 10-10 would receive general donation made to it. Finally, on the matter of whether there should be established an award for the leading non-10-10 participant(s) in 10-10 contests to encourage joining, the suggestion was withdrawn upon the general will of the Board without vote that no such award be established. (15-3-3)

On a proposal by Director Henderson, it was moved by Director Williams, with second by Matson, the Article III, Section 1 of the Bylaws be amended as follows: that the current line 1 be deleted and replaced by the follow text: "Any licensed amateur radio operator, who has operating privileges on 10 meters, may apply for membership." Implementation of this change will require commensurate changes on the *Ops Manual* and revision of the membership application by the Membership Committee to require self-certification in a form such as "I certify that under the terms of my amateur radio license I have operating privileges on 10 meters." The motion carried unanimously. (15-4)

Because of the excessive expense of bonding the Treasurer, the Board unanimously agreed, upon motion of Director Imsande with second by Matson, that Article IV, Section 1 of the Bylaws be amended by deleting the words "bonded and" from the first sentence. However, it was the will of the Board without vote that the Vice-President be designated as a third signature authority for

checks requiring multiple signatures as part of his or her duties to serve in the absence or unavailability of the President. (15-5)

Upon motion by Director Matson, with second by Secretary Cebik, the Board unanimously agreed to amend Article VIII of the Bylaws by deleting the present vacant Section 4 and renumbering Sections 5 and 6 to Sections 4 and 5, respectively. (15-6)

A proposal to amend Article XII, Section 2 of the Bylaws by Director Matson was withdrawn after discussion by the Board. (15-7)

In order to clarify election procedures further, upon motion by Director Miller, with second by Redwine, the Board unanimously voted to clarify Article IX, Section 4 of the Bylaws by adding the following sentence: "Whereupon having completed their task, the Nominating Committee shall be considered discharged." In further clarification of the same Article, Section 3, upon motion by Director Matson, with second by Imsande, the Board unanimously voted to change the phrase "in a timely manner" to the phrase "by December 15." (15-8 and 15-8a) A proposal by Director Imsande to set word limits to the biographical sketch required of each nominee was withdrawn, but the Board instructed the Secretary to alter the wording of the nomination form to include a 200-word limit on the biographical sketch. (15-8c)

Upon motion by Director Imsande, with second by Hagan, the Board unanimously voted to amend Article III, Section 5, "Cancellation of membership," by adding the following subsection: "(c) Conduct not becoming amateur radio in general or 10-10 in particular, as determined by the Board of Directors. This cause for membership cancellation may result in revocation of an individual's 10-10 number." (15-8b)

In order to ensure that all members, US and DX, participate fully in 10-10 elections, the Board discussed methods of sending out ballots. A proposal and motion by Director Imsande, with second by Henderson, originally intended to amend Article IX, Section 6, was amended with the consent of both the motion's principal and second to be a policy of the Board and an insertion in the *Ops Manual* in the appropriate chapter on election procedures. The Board then unanimously agreed to the following wording: "Ballots to US members shall be mailed via First Class Mail and Ballots to DX members shall be mailed via Air Mail." This wording formalizes as policy the procedure instituted for the 1994 elections. (15-8d)

The Board discussed two related fiscal matters: 1. increased service to members through first class mail of ballots and 10-10 News to US members and air mail mailing to DX members; improvements in the operating programs, including both contests and awards; and the creation of improved materials for members; and 2. increased costs of services, including rising paper and mailing costs (both at present levels and with anticipated further increases); lower interest rates on cash reserves; and numerous other rising costs of doing business. In consequence of these discussions, the Board unanimously approved a proposal by Director Henderson, modified in discussion and moved by Secretary Cebik, with second by Director Miller, that the following dues schedule become effective January 1, 1995:

It is understood that all figures are in US dollars. The Board also noted that between now and December 31, 1994, members would have the opportunity to renew their membership for any number of years at the current rates (\$7.00 US, \$9.00 DX per year) or to obtain

life membership at the current rates (\$175 US, \$225 DX). Director Barnes of the Communications Committee reported that no other major Amateur Radio Society (including ARRL, YARRL, YU1SSB, and QCWA) provided such extensive information and operating services for the cost of membership in this schedule. (15-9)

It was moved by President Lefcourt, with second by Director Matson, that beginning with the October, 1994, issue of *10-10 News*, all mailings of 10-10 to US members be via first class mail and all mailings to DX members be via air mail. The motion passed, with all voting aye except Director Williams, who voted nay. Although this new policy will be expensive, it will largely remove the delays and uncertainties associated with DX mailings. In addition, it will provide 10-10 with US address corrections automatically, and it will ensure the automatic forwarding of the *10-10 News* to members who have recently moved but have not yet notified 10-10 of their new address. (15-10-2) The first proposal from DX member William B. Howe, VK4WBH, to serve as a mail distributor for 10-10 mailings to Australian members in order to alleviate the long delays and uncertainties of surface mailing was deemed by the Board to have been resolved for all DX members by the decision to use air mail for all DX mailings. (15-10-1a)

DX member Howe also proposed the reintroduction of a VK/ZL Area Manager in order to alleviate the excessive expense of paying dues via the mechanism of International Money Orders. The Board recognized the seriousness of the issue raised by VK4WBH, but remained uncertain just how a VK/ZL Area Manager might alleviate the problem or reduce the costs to individual members. Therefore, on motion of Secretary Cebik, with second by Director Williams, the Board unanimously voted to refer the proposal to the Membership Committee, which is instructed to work with VK4WBH and other DX members with similar problems to devise a solution. The Membership Committee is further instructed to report back to the Board as soon as possible and not later than the next regular Board meeting. Further discussion of the matter noted that any new procedures devised by the Membership Committee and worthy of immediate implementation might be handled via phone or mail procedures for the conduct of business between meetings of the Board. (15-10-1b)

In consideration of where to hold the 1996 regular meeting of the Board of Directors, after discussion of several possible cities, Director Hagan moved, with second by President Lefcourt, that the Planning committee be directed to explore the possibility of holding the meeting in Denver, Colorado, by making contact with 10-10 members and chapters in the area. The Board unanimously approved the motion. (16)

Consideration of the 1997 Board meeting and National Convention site was deferred for want of any volunteer chapters to host the meeting. The Editor was instructed to request volunteer hosts in *10-10 News*, and the Planning Committee was instructed to make contact with potential host chapters. (17)

Under unfinished business, Director Imsande presented model certificates to be issued to all Life Members and to donors to the Scholarship fund. Upon motion to approve by Director Redwine and second by Hagan, the Board unanimously voted aye. (18-1, 18-2)

Turning to new business, Director Imsande outlined a potential new 10-10 Award: IOTA or Islands On The Air. The Operations committee was instructed to continue development of the award and to seek an Award Manager for it. (19-1) Director Miller followed with a report on the potential for a 10-10 County Hunters Contest and was instructed by the Board to continue development. (19-2)

Directors Imsande and Matson reported on designs and potential costs for standard W6OI Club Station QSLs. Director Imsande was instructed to continue development and to have cards printed for use by special events. (19-3)

Because the plaques issued for several achievement levels of the bar award cost more than 10-10 can reasonably charge and because members polled favored certificates in their place, Director Henderson proposed replacing the plaques with suitable certificates, with different colors for each level of award, each to be priced to members at the standard rate of \$2.00. On motion of Secretary Cebik, with second by Director Matson, the Board unanimously approved the proposal. (19-4)

Director Henderson presented a proposal to name, under a contract that would benefit 10-10 with a share of profits, Caps Unlimited, Gary Engleman, K5HGL, as the sole authorized distributor of 10-10 memorabilia. Each contract would run for no more than two years but be renewable. Caps Unlimited would submit to the 10-10's Board of Directors for approval a sample of each item, and to the Chair of the Finance Committee a list of items to be sold enumerating the proposed prices and the amount to be received from each sale by 10-10. Director Henderson moved approval, with second by Imsande. All of the members of the Board voted aye except President Lefcourt and Director Ellison, who voted nay. The motion carried. (19-5)

The Board instructed Director Williams and the Membership Committee to revise the Membership Application form to a. update the information about 10-10 and b. include among the data requested of the applicant a certification in a form such as "I certify that under the terms of my amateur radio license I have operating privileges on 10 meters," in accord with the previously passed amendment to the Bylaws, Article III, Section 1, that requires any licensed amateur radio operator applying for membership to have operating privileges on 10 meters. (19-6)

Director Henderson made a proposal to ensure continuity of the records keeping by 10-10 in the form of the *Ops Manual* and the archival files, namely that the tasks of maintaining the *Operations Manual* and the archival files be removed from the assignments given to the Secretary and be assigned by the President to a qualified volunteer, such assignment being subject to approval by the Board of Directors. A motion to approve was made by Director Matson, with second by Imsande, and the Board unanimously voted aye, with the Secretary abstaining. The Secretary was instructed to enter this policy into the *Ops Manual*, revising the section on the duties of the Secretary accordingly. (19-7)

Director Henderson also proposed the creation of an executive committee to automatically advise the president on critical and time-sensitive matters that might arise between meetings of the Board of directors. After extensive discussion by the Board, the sense of which was that the President already possessed the authority to create such committees as would serve the interests of 10-10, the proposal was withdrawn. (19-8)

Returning to item 14 on the agenda, the Board heard a detailed description of plans for the 1995 National Convention of 10-10 to be held in Tuscaloosa, Alabama, June 17 and 18, 1995. Registration will begin Friday, June 16, the same day that the regular meeting of the Board of Directors will be held. An extensive program of forums is planned, with a continuous hospitality suite, a chapter meeting room, and a banquet with suitable prizes and entertainment. Members of the Board will be free to fully participate in the activities of the 17th. Director Henderson will provide further details as they become available. Unlike recent conventions, the 1995 meeting will be devoted exclusively to 10-10. The Board expressed its thanks to Director Henderson for his work on the Convention and informally pledged its support for the work yet to be done.

This issue, as voted by the Board, is coming to you via First Class mail in the US and by Air Mail to DX. Perhaps it is more likely that propagation appeared to be poor because interest in 10-meters has dropped with the solar flux. Propagation looked great in four-land but over three quarters of the logs were from one chapter - Possum Trot.

I spoke to Bill Kelcher, KU4W #20986 at the 10-10 forum at Dayton. Bill described how he has slowly built his chapter by developing interest in 10-10 following the true spirit of 10-10 International. In effect, it appears as though the Possum Trot group created propagation in the southeast! If there were that interest in the other 9 call areas we would have seen 400 logs!

If you are unhappy when hams support "no code" then you should support the CW QSO Parties. The speeds are reasonable and an imperfect list will go unnoticed - but it's not fun when you are on the air all by yourself....

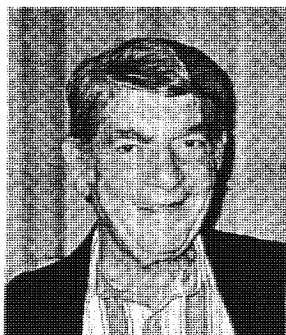

10-10 Historian



Congratulations to the participants and the chapters who persevered to earn the distinction of being number one in the 10-10 QSO Parties. This remarkable achievement merits the recognition they deserve when the contest results are announced in the *10-10 International News*.

The results of the seemingly first 10-10 contest were announced in a one-page *10-10 Bulletin*, previous name of the *10-10 International News*, postmarked December 17, 1971.

"FROM OUR CONTEST MGR., Joe D. Brown, W5KZT: In our recent contest the final winners were: VE5LI, Fred Leeks, 529 points., K5MRU, Grace Dunlap, 513 pts., VE5SM, H.J. Slacky, 447 pts. The European winner was Don Morgan, 69 pts. For solely mobile operation: Jack Fern, 61 pts." (The call letters for Don and Jack were not listed.)

Grace Dunlap, K5MRU #218, assumed the office of Contest Manager in 1971 and served with distinction in that capacity for seven years. In the early '70's, the *Bulletin* was published infrequently. It was indeed fortunate that Grace succeeded in having the 10-10 contests announced in the ham magazines, *CQ*, 73 and *QST*.

The results of the 10-10 International Net Contest of February 3-4, 1973, required a complete page in the November 1973 *Bulletin* to list all of the participants. The *Bulletin* was starting to emerge as a quarterly publication. The announcement of the upcoming contest February 9-10, 1974, also appeared in that issue. Here is a list of the winners of the 10-10 Contests managed by Grace, K5MRU.

Unfortunately, this work load exceeded her spare time, and in 1978, she reluctantly resigned as Contest Manager. The Minute Man Chapter volunteered to fill the void. Robert Mugerini, W1AKS #8969, as Tabulation Committee Chairman, managed future contests. In addition, Chuck Elliott, W8URK, as QSO Party Rules Chairman, announced upcoming contests in the *Quarterly Bulletin*.

The first CW QSO Party took place in the summer of 1978. It was planned by Dan Rubin, WA1ZXB, who also served as the 10-10 CW Contest Manager. The results of this contest appeared in the Winter 1979 *Bulletin*. Dan tabulated a total of 27 logs listing 636 CW QSO's. The winner was AB5X with 91 QSO's. The Sky Blue Waters Chapter was Number One, credited with a total of 106 CW QSO's.

They were the best of times, they were the worst of times.

you imagine all of these letters that I had to memorize? I thought to myself that if I wanted to pass the FCC test that Mr. Condon told us about, I should never give up and that's what I was about to do.

Weeks went by. I was worried how hard it would be to pass the test. Before I knew it, I was back in the classroom taking the sample test from the tape. I started to copy. It was only about 6 minutes but it seemed like hours. When it was all over, I covered my eyes before I looked at what I had copied. Then I opened my eyes to look...WOW! I never thought I could do it so well. I got 100%! Mr. Condon asked if anyone got 100%. I raised my hand. He said, "Garrett, you are ready to pass!"

The day had arrived! It was time to go and make it happen! My dad wailed me down to the school testing center. I was sweating like a hot dog in the sun. I was nervous and wondered if I would pass. I had to pass! I filled out the form to send to Gettysburg, PA..... If I passed.

The examiner was preparing to send the code. I was worried! I listened...copied...listened...and copied. When it was over, doubting everything...looked at my paper. Whoah! I thought I was almost dead. The examiner approached me and handed my test. I looked straight at my score. I got 100%. I was shocked! I was on my way to becoming a real ham.

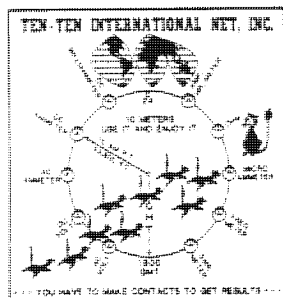
