## **ELECTION 2006 BALLOT INSIDE**


I can't emphasize how important that you make a vote for the candidate(s) of your choice.

#### 2006 Elections

Are you going to vote? The 10-10 International Net 2006 Election is upon us. Your ballot is included in this issue of the NEWS. In fact, this issue of the NEWS is full of information about the upcoming election.

This year's election is for the offices of President, Secretary and four (4) Directors. Be sure you read the ballot instructions carefully. Ballots must be completed correctly and must be returned by the specific deadline stated in order to be valid.

The Nominations Committee led by Director Rob Ireland. VE9KM, #69811, has submitted a list of qualified candidates for the election. Other members of the Nomination Committee were Ruth Bartholomew, N0KDB, #48715, Marcus Lieberman, KM5EH, #71103, and Bob Farrow, N6OPR, #45715.

At the time of writing this article there is still time for other interested candidates to petition for inclusion on the ballot. Any such candidate must petition for nomination by acquiring 50 current 10-10 member signatures to support their candidacy. Petitions for candidacy must have been submitted to the 10-10 Secretary by July 1st in order to qualify for the ballot.

This issue of the NEWS includes a listing of all candidates and a short biographical sketch on each candidate. Please read about these individuals and their thoughts and plans for 10-10 International. The winners of this election will lead 10-10 for the next four years. Be an informed voter - but above all make your voice heard.... VOTE!

#### **Board of Directors Meeting**

The 2006 Board of Directors meeting was held in Omaha, NE, on June 6th. All members of the Board were present with the exception of two members who were excused for medical reasons, and one Director that was excused because of a scheduling conflict. In addition to the Officers and Directors, the Treasurer, Data Manager and General Counsel attended the meeting.

A lot of material was covered during the meeting, and some exciting and very important issues were voted upon. The minutes of the meeting, when complete and approved by those in attendance at the meeting, will be posted on the 10-10 website (www.ten-ten.org) and in the next issue of the NEWS. Some of the highlights of the meeting included:

General Counsel, David Splitt, KE3VV, #69831, reported on his review of the 10-10 International Net Bylaws. His report included both corrections and suggested revisions to the document. After much discussion, and a section-by-section review of the comments, the

revisions to the Bylaws were adopted. The Bylaws, as revised at the June 6th meeting, have been posted on 10-10 website. Take a look at the Bylaws and if you have comments, please contact a current Board member.

A site for 10-10's biannual convention has been selected. The 2007 10-10 convention will be held in Omaha, NE. It is not too soon to begin making your plans. The chair of the convention is Gerry Gross, WA6POZ, #21274. Gerry will be posting information for the convention on the website and in the 10-10 NEWS as details are finalized. The Board wishes to express its appreciation to all of those members that took the time and made the effort to prepare proposals for a 2007 convention site.

The Board of Directors reviewed the 2005 member survey in detail. The Board was very pleased that so many of 10-10's members participated in the survey. Each Director reported on the comments that impacted his/her committee. The survey results provided several new ideas that the Board discussed and enacted. The survey was so successful that the Board intends to use this method in the future to poll members on other issues of interest. Please check the 10-10 website regularly to assure that you get to provide your input.

A new digital award was approved. Director Brad Kimble, K0DBK, #55192, will provide details on the award soon. The information will be posted on the website and included in the 10-10 NEWS. Mel Sojka, KD5DE, #33513, has agreed to serve as Award Manager for the new award program. Thanks Mel!

One of the true highpoints of the meeting was the Scholarship Foundation report. The Board voted to increase 10-10 annual scholarships for the upcoming year to six (6) \$1,000.00 scholarships! Each 10-10 member should get a pat on the back for this achievement. It is only through your willingness to support this program that 10-10 has been able to bring the gift of education to so many. If you would like to add your support to this very important program, please contact 10-10's Scholarship Manager, Larry Berger, WA2SUH, #407. Larry will provide you with the details of the program and tell you how you can support this very worthwhile program.

The 2007 Board of Directors meeting will be held in conjunction with the biannual convention in Omaha, NE. The Board encourages all interested members to attend each meeting. The agenda for the meeting will be posted on 10-10's website by May 1, 2007. If you are going to attend the convention, why not stop by the Board meeting and find out what your elected officials are doing firsthand? 10-10 International Net members are always welcome. The convention will also host a Board of Director's forum. Please plan to attend that meeting too, and bring your questions and comments. 10-10's Board of Directors is making every effort to communicate with members on issues of concern.

The summer of 2006 is shaping up to be a busy one for 10-10 and its members - election, new digital award program, enlarged scholarship program, etc. To top things off, 10-meter activity increased in May and June, PSK-31 activity on 10-meters is alive and well, and Cycle 24 is just around the corner. Yes, activity is picking up for 10-10 International and its members.

Please don't' forget to vote in the election. This election is very important to the future of YOUR organization.

Above all, keep that radio on, and on the 10-meter band, and let's make contacts!

## New 10-10 Digital Award

I am sure that by now, many of you have heard of the new award that 10-10 has to offer. During the June 2006 10-10 International Board of Directors meeting, the new 10-10 Digital Award was proposed and approved. I might add that the approval was unanimous by all members present. As a matter of fact, everyone was pretty darn excited. What I wanted to do was give everyone a chance to hear about the award before the start date, which by the way is August 1, 2006, as well as a little on the background of how it came about.

After last year's convention in Mesa, two surveys were put together and submitted to the membership. One was specifically about the convention and the other was more general in nature. One of the questions on the general survey was, "Do you take part in 10-10 awards?" Answers ranged from yes to short narratives on the lack of propagation. One person suggested we have separate awards for CW and PSK

In the fall I received an email specifically suggesting we consider an award covering several of the digital modes of communication; in particular PSK-31. With the continuous emails on the Ten-Ten reflector about PSK-31 and these suggestions I began wondering if there might be a little more to it then I thought.

I decided it was time to do more than think. An email was sent to a person I consider an expert in the digital arena. This is due to the time he has put into learning the modes, his unending willingness to be on the air and always being available to anyone wishing to learn about the digital modes. I am referring to my friend Mel Sojka, KD5DE, #33513. I believe he responded to my email within at least 30 minutes. It was as if he was waiting to hear from me.

We began discussing our options and agreed that we must get underway with a plan. I asked if he had anyone in mind to assist (being 10-10, we needed a committee). He suggested two members that he considered to be very knowledgeable and perfect to help with the task. They were Jeff Steinkamp, N7YG, #65084, and Bill Heberling, WD5EDR, #23693. I could do nothing but trust Mel's judgment. He did not let me down. By the way, these three along with me made up the committee for the new award, but Mel told me that he consulted with others as well. In Mel's words, "it is truly an award for the members by the members." Everyone went to work immediately formulating thoughts and ideas on how to put the award together.

One way that Mel received contributions from other members was in the form of a survey. The questions he asked were simple. If the Board of Directors approves a new award at the upcoming board meeting in June, considering current band conditions and the traditional propagation forecast for the near future, should contacts be retroactive for: 6 Months; 1 Year; or not at all (contacts beginning around 1 July 2006). I am not sure what the percentages were, but it was very clear that the majority of the members agreed to a future date for the new award.

With the survey as a reference and some very good contributions, the proposal began to take shape. Mel, Bill and I drafted the requirements for the award, keeping in mind the intent of 10-10's program requirements. Jeff went to work on designing the certificate and logging sheet. Several emails over a 3 month period were exchanged in putting the digital award together and having the proposal ready for the BOD meeting. Listed here are the rules as they were proposed to the BOD:

The initial certificate is awarded for a minimum of 25 contacts with Ten-Ten members. Cost is \$2.00 USA and \$3.00 US for DX

members

All contacts must be made using one of the following acceptable modes. These modes allow for the proper Ten-Ten exchange as prescribed by the Ten-Ten award general rules. Future modes that allow this exchange will be considered when they become available.

TM FSK Modes (AMTOR, G-TOR, TOR, THROB. RTTY, MFSK16)
TM PSK Modes (PSK, CLOVER, PACTOR, PACKET)

There will be two endorsements available for the basic award, PSK and RTTY. The basic award is required to earn these endorsements. However, if the requirements for the endorsements are met on the basic award application, the endorsements will be issued at the time of basic award issue. These endorsements will be issued with 10 contacts in these two specific modes. For these two endorsements only, a contact worked can be used in either or both of these modes.

Bar awards will be issued at 50, 75 and 100 contacts. After 100 contacts bar awards will be issued in increments of 100. For the bar awards any of the acceptable modes will be allowed for the contacts, but a contacted station can be counted only one time.

All stations must be contacted from the same country and all contacts must have occurred since 1 August 2006.

Applications for the basic award should be submitted on the forms provided or photocopies thereof. Computer generated reports that contain the entire required input are allowable. Forms are available from the Awards Manager with an SASE. Forms are also available from the Ten-Ten website. The basic award will be available via Postal Mail only. Bar awards and endorsements can be applied for via email applications, using the prescribed format.

The award program has be designed as to allow for future awards that MAY include a WAS, DX and Grid program. Future awards will be determined and added as the need arises.

- · QSL confirmation is NOT required for the digital award.
- $\cdot$  Ten-Ten award general rules as prescribed on the Ten-Ten website and requirements are applicable.

One thing about this award is that no matter what class of license you hold, if you have the privileges to operate on 10 meters and have your 10-10 number, you can earn it. It doesn't take contesting type equipment to operate in a digital mode. You will find the majority of members on 28.120 Mhz.

And so, here we are. I have seen a few comments about the upcoming award on a couple of the email reflectors and they have been positive. If anyone needs assistance in getting started in the digital modes, I highly recommend contacting Mel, Jeff and Bill. They have been of great help to me in my efforts to get on PSK-31.

## **ELECTION 2006 - CALL FOR NOMINATIONS**

As you may be aware, 10-10 International holds an election every two years. In the year 2006 we will be electing the President, Secretary and four (4) members to the Board of Directors, whose terms will commence January 2007. This is a very important time for 10-10 as an organization. We need members to realize that the organization does not run itself and the desire to have qualified members serve is paramount. Nominations must be sent to the Nomination committee prior to May 1, 2006. The Nominating Committee shall develop a slate of eligible candidates by June 1, 2006. The chairman of the committee will provide to each potential nominee information regarding eligibility and specify what information to send to the committee. Members selected by the Nominating

Committee will be notified, in writing, by the chairman of the committee. Members not selected by the committee may petition for candidacy by having a petition signed by 50 full members and presented to the Secretary by July 1, 2006. A nomination information form is required and is available from the Nominations Committee Chairperson. Further questions concerning the election/nomination process may be addressed to Rob Ireland VE9KM Nominations Committee Chairman, 31 St. James Street, Sackville, NB, E4L 4L7 Canada or via e-mail to rireland@mta.ca.

Qualification for Nomination to be an Officer or Director of 10-10: In accord with the bylaws, no member of 10-10 may qualify for nomination to be an Officer or Director of 10-10 unless he or she has been a full member for more than four (4) years immediately preceding his/her Nomination and that he/she can show that their membership will remain current during the period of the office they are seeking. The Nominating Committee or petition for candidacy are the only methods to be used by members who wish to be nominated.

Selection by the Nominating Committee: The Nominating Committee is charged with the task of selecting from those who indicate a desire or willingness to serve as an Officer or Director and to form a slate of candidates which the committee believes represent the best qualified candidates from information submitted to the Committee.

**Petition for Candidacy:** Members and nominees not selected by the nominating committee may petition for candidacy. Such petitions shall be signed by 50 full members and submitted to the Secretary by July 1, 2006.

**Biographical Sketch:** All candidates, whether selected by the Nominating Committee or by petition, must submit a biographical information form and biographical sketch. The Nominating Committee will use this information in the process of selecting a slate of candidates. Those who petition for nomination must submit a biographical information form to be provided by and returned to the Secretary. This biographical outline, not to exceed 200 words of narrative, shall be printed in the July 2006 issue of the 10-10 News.

**Notification of Potential Nominees:** Members selected by the Nominating Committee to be candidates shall be notified in writing by the chairman of the Nominating Committee. The chairman of the Nominating Committee shall also notify, in writing on or before June 1, 2006, members who are not selected by the nominating committee, and inform them of the proper method of placing their names in nomination by petition.

## An-Ten-Ten-nas

INFORMATION TO HELP YOU DECIDE ON THE BEST ANTENNA FOR YOU

In each issue of the News, we shall try to clarify a significant cluster of ideas used in antenna work. Our object is to help you make the best decisions about the antennas you buy or build without imposing our own prejudices on you. The more you understand, the better your choices will be.

#### No. 52: Gain vs. Beamwidth


Antenna ads are long on gain numbers, but woefully short on other important data. One of the major absences is a beamwidth specification. Omitting this information has led some wire antenna makers to advertise their wares as having on some bands more gain than a 2-element Yagi. They do not say in what direction the gain occurs relative to the fixed-position wire antenna and they do not say for how much of the horizon the gain number holds true.

If you use a rotatable Yagi or similar array, beamwidth has only secondary importance. For the size beams that are practical on 10 meters, the beamwidth will vary from about 65° for short-boom arrays to about 50° for long-boom Yagis. What these numbers tell us mostly is that super-precise aiming is not too important, since the gain variation from mis-aiming will not be detectable within about +/-10° of the target bearing. However, if we have a fixed-position antenna that is horizontal, then beamwidth takes on added significance.

Fig. 1 shows a typical azimuth pattern for a 2-element Moxon rectangle only to show what we mean by beamwidth. The vertical centerline on the plot shows the direction of

maximum gain. At some angle on either side of this line, the gain level will be 3-dB lower than maximum gain. These two points are called "half-power points." The angle between the halfpower points defines the antenna's beamwidth.

If we cannot rotate or switch our antenna to place the main beam where we wish it to be. then beamwidth becomes an




Azimuth Pattern and Beamwidth

important consideration in selecting an antenna for 10 meters. In general, we want to be able to communicate over more of the horizon than we want to leave unattended (because no one lives in those directions). To ensure that we cover the complete horizon, many operators with limited space use vertical antennas and accept the reduced gain as the cost of coverage.

There are too many different antennas to explore beamwidth factors in this short column. So let's take the extreme cases. One of those cases concerns 80- and 40-meter wires, about which manufacturer advertising tends to make misleading statements. The product is usually a 135' (or thereabouts) wire which is resonant on 80 meters and usable on all bands--a very old antenna indeed. The antenna in principle can be fed at the center, at one end, or at a position between, called off-center-feed.

Fig. 2 shows what happens when we take readpoint was Azimuth any of these three feed Patterns systems and run the antenna on 10 meters. The maximum 10-meter gain runs between 10.5 and 12.3 dBi, depending on the feed system. However, as the halfpower lines on strongest lobes show, the gain applies only to selected lobes at a wide angle from broadside to the wire--which runs left to right across each pattern. The beamwidth for any of the feed systems is only about 20° wide. In many parts of the US, a 20° beamwidth will not cover all of Europe, assuming that you set up the antenna in exactly the right way. If we factor in wire sway during brisk breezes, we may find that signals vary widely in strength without changes in the



There are a number of fixed wire antenna designs that offer considerably more gain and a predictable direction for it. Many operators with budget constraints feel drawn to such antennas because they are cheap, fixed, and relatively easy to build. For example, we need not use aluminum tubing for Yagi elements. With proper design, we can have a high-gain 10-meter Yagi

made from wire. Suppose we could have nearly 15-dBi forward gain with a high front-to-back ratio with an antenna that uses very little more wire than the 80-meter doublet.

desired gain. Note that the side and rear lobes have very low strength, giving us excellent forward performance. However, beamwidth is only 47°. This antenna is for special purposes, for example, if we desire to communicate regularly in only one direction. There are numerous operators who maintain regular schedules with family members or colleagues. Others specialize in contacts with only one part of the

world. For such folks,

this type of antenna may


be ideal. However, for

the general operator, the

antenna gives up over

85% of the horizon.

I recently saw on the internet some hype for a 10-meter Sterba curtain. The antenna was promoted as having very high gain and also as having multi-band capability. Unfortunately, on all



bands other than the one for which the antenna is designed, the patterns, elevation angles, and gain are mediocre. The Sterba curtain arose in the early days of short-wave broadcasting as a bi-directional array with high gain on a selected frequency. In commercial and government circles, the array has fallen out of use in favor of arrays that show a single directional pattern and some frequency nimbleness (such as the LPDA). An alternative is the electrically steerable array.


However, suppose we build the complex array composed of phased sections and end half-sections for only 10 meters. The question is what we may have if we successfully construct a Sterba curtain. The answer is two main lobes broadside to the wires. Each lobe shows a maximum gain of over 15 dBi. However, the beamwidth shrinks to 26°. The general arrangement of the antenna appears in Fig. 4. Invisible in the

outline sketch is the fact that each vertical length of wire (except the end wires) is actually a phasing line consisting of two wires with a constant but relatively close spacing, that is, a transmission line. The pattern shows the main lobes and the narrow beamwidth. If you happen to live directly between two stations with which you wish to communicate regularly, a Sterba curtain might beuseful. However, the cost is 85% of the horizon.

Perhaps the king of all directional wire arrays by reputation is the rhombic. Fig. 5 shows the outline and the pattern. Each leg of the rhomboid is multiple wavelengths long, and the designer carefully calculates an angle between legs to yield maximum gain. Called a "traveling wave" antenna, the point

furthest from the feedpoint has terminating resistor, ordinarily about 600-800 and capable dissipating at least half the power supplied to the antenna.

The rhombic's pattern shows very high gain, almost 18.5 dBi in this design case. For the SW broadcaster special communicator of the 1930s, the antenna allowed a very narrow Fig. 5 beamwidth for point-to-



point fixes. In fact, the beamwidth is under 11°. If I had the space and desired to communicate with a single city (or perhaps the city and its suburbs), the rhombic might be the antenna of choice. However, for the general operator who wishes access to the entire world, the rhombic is one of the poorest choices possible. The only way to use a rhombic for horizon-wide communications is to mount it in an ocean on a rotatable island.

These notes are designed to alert you to the temptations of gain at the expense of other important specifications that affect our operations. If you cannot install a rotatable antenna due to rotator/tower costs or deed restrictions, then perhaps a vertical or vertical array may be in order. Alternatively, you might be able to manage a TV mast to 20' or more above ground and mount a self-supporting dipole at the top. Then, you may hand rotate the dipole to be broadside to the desired communications path. With its 80° beamwidth for each of the two lobes, you would not have to move the antenna direction very often during the day, and you might lower it out of sight when not in use. (Hang some flags, pennants, or mock laundry from the element to disguise the antenna's true function.) The idea is to swap gain for a wide beamwidth to gain access to more of the horizon and hence more communications targets. Beamwidth does make a difference.

If the comment had a major concern for 10-10ers, I have asked the Chapter Committee for their thoughts on the concern and will make recommendations to the BOD for possible change/adoption.

As I have told you in the past, when submitting your quarterly report, you need only include those items that have changed since the last one. I would recommend that, as part of your chapter's records, you have a copy of the last report submitted to aid in sending a new one. You can see later in this article, I maintain a suspense file of quarterly reports submitted. BTW, I do read the reports when I get them, so anything that is happening within your chapter that might be of interest to your chapter members can be listed in the "Comments" section.

The hyperlink section of the 10-10 website is well used by 10-10 members, so, if the hyperlink to your Chapter web page has changed, please let either K5CC or me know, so that we can get it changed on the 10-10 website. I also check the URL line on the quarterly report, so please include your hyperlink there if you have one.

If you maintain the records for your chapter and something happens so that you are no longer able to continue to do so, and you want your chapter to continue, please have the records maintained in such a way that they can be passed on. Although it is great to do so, the maintenance of a chapter in a certain area is not a requisite any longer. In other words, if a chapter based in such as area can not be continued in that area, someone outside the area can take it. Recent examples of this happening are the Space Coast and Santa Fe Trail Chapters. Someone made an offer to pick up one of the other chapters that was recently QRTed, but, as the records were not available, this was not possible

#### **Submission of Information:**

This column must be in to the editor of the NEWS no later than the first week of the month of March, June, September, and December. So in order to make the deadline and, if you want your chapter information in the current issue, it needs to be in hand by the last day of February, May, August and November. Keep in mind that sometimes the newsletter is delivered a few days into the month rather than being on the 1st, Therefore, if you have a special or worksheet that is going to be done during the months of January, April, July, or October, then the information needs to be in to the Chapter Manager in the prior issue.



The news in the DX world is what will happen to the old Yugoslavia now that Montenegro and Serbia are parting ways. In 1992, Montenegro went into a federation with Serbia. On June 3rd the Parliament of Montenegro declared the independence of Montenegro, which confirmed a vote held on May 21st. Montenegro has now begun the process of getting world recognition and membership with international organizations, like the UN. Now for DXCC status two things can happen to give them new country status. If the UN gives them membership or the ITU grants them a callsign prefix, that will automatically make it a new DXCC country. This process could take a few weeks before the ARRL DXCC adds Montenegro to the DXCC list. Serbia is already a member of the UN so its DXCC status will not change. The DXCC will probably change its name from Yugoslavia to Serbia on the printed list of countries.

There is an E7 and E9 prefix that can be allocated by the ITU for Montenegro. There is always the possibility that the old YU prefix could become obsolete if Serbia requests a new prefix. Assuming that Serbia continues to hold its current seat in the UN, it will remain on the DXCC list as a pre-existing and continuing DXCC country. Then the next question will be, "Do I have to work them again for DXCC credit?" Assuming you already have credit for YU, you will have credit for Serbia. Therefore, you will only have to work the new Montenegro for a new credit effective after the date they get UN membership or the ITU prefix. Just wait and see what rules are adopted by the ARRL DXCC.

Last quarter we talked about the poor solar conditions and how they are adversely affecting the band. DX conditions have not improved except for some stateside summer skip that has helped bring back some life to a quiet band. I did see a report this week that there was an opening from Europe to the US and a few days before that, Japan worked into Texas. I noticed that my online logbook has a lot fewer contacts in it compared to last year at this time. Most of the big DXpeditions did most of their work on the lower frequencies but keep watching the beacons for your window of opportunity. You can see the solar progress and graphs at this NOAA site: www.sec.noaa.gov/SolarCycle/

I worked only a few stations during the 10-10 Spring CW QSO Party last month as I could not operate Saturday. The propagation was poor and I only had one opening on Sunday. Jack's K5CC Hill Country Picnic was held on May 28th, and they had a nice afternoon net with many check-ins. I worked seven

new members and a one new county for my log. Last year I could not hear Jack at all on backscatter and he is about 150 miles west of Houston.

Countries Award: There are now a total of 617 basic certificates. I issued 10 upgrades and 3 basic awards this past quarter to eight people. Upgrades cost nothing but an SASE and you can copy your QSL and eQSL cards instead of sending the originals. Copies are not returned to save postage. See the website for more details before you send your application and please email any questions to me.

The count of 10-10 countries worked remains at 313 confirmed and 26 countries without any 10-10 activity.

**Propagation:** Average daily solar flux for April 2005 to April 2006 was 85.9, 99.5, 93.7, 96.5, 92.4, 91.9, 76.6, 86.3, 90.8, 83.4, 76.5, 75.5 and 88.9. There are still a few DX openings, but they are hard to find. Expect the daily solar flux will range from 64-91 and the average monthly flux will stay below 88 until Solar Cycle 24 begins in 2007.

Cycle 23 is ten plus years old. The flux remains in its lowest range with many days of zero sunspots and resulting in few DX openings. On June 12th, the solar flux was 74 the A index 6 and K index 1 which is two points higher than three months ago.

Expect the best conditions on June 11-13th, July 8-10th, August 4-6th, and Sept. 1-3rd. Starting in June, USA stations, expect a 5% chance of DX to Asia, Europe or Africa and a 10-15% chance of working into South America or Pacific in the afternoon. To tell what DX paths are open, use the beacons from 28.175-28.300 (especially 28.200).

## 10-10 International Net, Inc. 2006 Board of Director's Meeting

#### June 6, 2006 Carter Lake, IA

Vice-President Mike Elliott, K7BOI, called the 2006 10-10 International Net Inc., Board of Directors meeting to order at 8:03 a.m. on June 6, 2006, at the La Quinta Inn in Carter Lake, IA. Present were Vice President Mike Elliott, K7BOI #54625, Secretary Jon Goering, NJ7I, #43483, Director Brad Kimble, K0DBK, #55192, Director Cliff Taylor, K5FBS, #48461, Director Larry Berger, WA2SUH, #407, Director Jack Moore, K5CC, #50708, Director Joe Williams, WA9TSG, #310, and Director Rob Ireland, VE9KM, #69811.

Data Manager Gerry Gross led the members present in the pledge of allegiance to the flag. An opportunity was provided for recognition of any other 10-10 member country. A moment of silence was observed in remembrance of recent Silent Keys. Special note was taken of former 10-10 Secretary Dick Corlew, NC6V, #25057, and other noted 10-10 members - Don Ruf, KB0ON, #29849, Bobbie Vaughan, WB7NUU, #17416, Grace Dunlap, K5MRU, #218, and Teresa Mycko, KA4HOY, #29125. Roll was called by Secretary Goering with all members present except President Chuck Imsande, W6YLJ, #19636, Director Doris Slye, N3TGB, #68129, and Director Steve Rasmussen, N0WY, #68684. These Board members were excused from the meeting either for personal or medical reasons. Invited guests present were Treasurer Keith Schlottman, KR7RK, #63324, General Counsel Dave Splitt, KE3VV, #69831, and Data Manager Gerry Gross, WA6POZ, #21274. A sufficient number of Officers and Directors were present and a quorum was established.

There were no additions, corrections, or deletions to the Agenda.

A motion was made by Director Ireland and seconded by Director Williams to approve the minutes of the Board of Directors meeting held June 9 and 10, 2005, as they were published in the 10-10 International NEWS. Motion carried.

Vice President Elliott discussed President Imsande's current medical leave of absence. President Imsande has asked that the medical leave be extended through December 31, 2006. Officer and Director yearly reports were circulated prior to the Board meeting by e-mail and did not require review.

A motion was made by Director Williams and seconded Director Berger to accept Jon Goering, NJ7I, #43483, as 10-10 Secretary, Randy Camron, AJ5ZX, #71083, as Worked All Continents Manager and Leslie Johnson, WA4EEZ, #15675, as an addition to the Contest Committee. Motion carried.

#### **Old Business:**

Director Ireland led a discussion of the 2006 election process. He explained that the Nominating Committee consisted of himself, Bob Farrow, N6OPR, #45715, Marcus Lieberman, KM5EH, #71103, and Ruth Bartholomew, N0KDB, #48715. The

committee received nominations and inquiries from any interested member. Nomination forms were sent out and responses received back by the committee. The Data Manager was contacted to check the dues status of all potential candidates. The committee reviewed all nomination biographical sketches and made minor editorial changes. As required by the 10-10 Operations Manual, Director Ireland submitted the committee's recommended candidate names to the appropriate officials. He also notified all successful nominees of their selection. Biographical information for each candidate will be provided to the Editor for publication in the NEWS. The Nomination Committee's recommendations are as follows:

Director Ireland led a discussion regarding the form now being used by the Nominating Committee. He believes that the present form is lacking and should be recreated so that it can be more universally used for future elections. Director Ireland and the Nominating Committee will work on form revisions and provide a recommendation at the 2007 Board meeting. Other Board members were encouraged to send comments or suggestions for the form to Director Ireland.

Data Manager Gross discussed the election ballots and the potential for electronic voting. All ballots will be included in the next issue of the NEWS. Ballots will be returned to a special election Post Office mailbox. He also reported that he has looked into electronic voting and that additional work must be accomplished before this becomes a viable voting method. General Counsel Splitt suggested that 10-10 check the MARAC electronic voting system. It has been used successfully for several years.

Vice President Elliott led a discussion regarding the election teller. Since all election ballots will be returned to an Omaha address, 10-10 has attempted to locate tellers in the Omaha area. Richard (Dick) Newsome, W0HXL, #8675, has agreed to serve a lead election teller and will get additional local people to help count ballots. W0HXL and his group will count the ballots and then notify the Secretary of the results, as required by the 10-10 Operations Manual. A motion was made by Director Taylor and seconded by Director Williams to approve Dick Newsome, W0HXL, as lead teller for the 2006 election. Motion carried.

Director Williams lead a discussion regarding a 10-10 convention and the site selection process. He asked Treasurer Schlottman to report on the 2005 convention. Treasurer Schlottman stated that the Mesa convention was a success. That convention brought in more money than in the past, but there were also more expenses. Director Williams discussed the various locations that had been proposed for the 2007 convention. One

site proposed, Baltimore, MD, submitted a written proposal. The Convention Committee and the Board of Directors evaluated the proposal. The consensus was that costs associated with the Maryland site were too high to attract members. Other sites under consideration were in Colorado, Wisconsin, and Nebraska. Only Nebraska came forward with a definite proposal. Data Manager Gross discussed the potential for holding the 2007 convention in Omaha, NE. He discussed the expected costs, available facilities, area attractions, entertainment opportunities and potential convention dates. Because of other conventions in the Omaha area, the best possible time for a 10-10 convention is August. The Board then held a general discussion of issues surrounding a convention - financial considerations, potential costs to 10-10 and potential future sites.

Vice President Elliott declared a break at 9:39 a.m.

Board meeting resumed at 9:46 a.m.

A motion was made to hold the 2007 10-10 International convention in the Omaha, NE, area by Director Williams. Director Taylor seconded the motion. Motion carried.

Vice President Elliott discussed an e-mail he had received regarding the possibility of holding the 2009 10-10 convention in England. A 10-10 member in the U.K is exploring this idea. The Board discussed the idea of holding mini-conventions in much the same way as MARAC does. This could allow many more of the DX members to participate in 10-10 convention activities.

Treasurer Schlottman reported on the replacement of the Corporate Secretary with a California Resident Agent. 10-10's Resident Agent is an attorney and charges a flat fee to file the necessary annual reports with the State of California.

Director Ireland reported on the possibility of initiating a DX equivalent of W6OI. He has checked into the Canadian rules and discovered a few problems associated with establishing the call sign, ownership of the call sign, trustee issues and costs. Director Ireland agreed to pursue this issue further and report to the Board at the 2007 meeting.

Data Manager Gross reported on current membership and his use of incentives. 10-10's membership has been slowly declining. This appears to be due to propagation and the overall decrease in amateur activity. The current active 10-10 membership is slightly lower than 5000. During the last two quarters over 100 letters have been sent for renewals. The response to these letters has been less than a dozen. He has used patches, pins, etc. as giveaways to encourage renewal. At Dayton he gave away the 10-10 Antenna book for 3-year renewals. He encouraged Board members to get involved in their local clubs and get the word out about 10-10 International. Treasurer Schlottman discussed the importance of a 10-10 presence at Dayton Hamvention. He discussed the visibility that Hamvention gives 10-10. Data Manager Gross mentioned that a 10-10 PowerPoint presentation is available for general use. He will send a notice to 10-10 officials announcing the availability of this presentation.

Director Moore discussed the need for 10-10 to participate in public relations and advertising activities. In 2005 and 2006 10-10 advertised in QST at a cost of \$124.00. He discussed adding a line to direct interested parties to a website where a past copy of

the 10-10 News could be downloaded or read online. Director Moore volunteered to discuss this idea with the 10-10 Webmaster. Director Moore made a motion to approve one more year of advertising in QST. The motion was seconded Director Kimble. Motion carried. Director Moore agreed to work with the Webmaster to attempt to track responses to the QST advertising. Director Moore led a discussion surrounding the need for forming a Public Relations committee. He suggested such a committee be formed. Vice President Elliott asked that the Data Manager Gross, Director Berger, Director Taylor, Director Moore, and Treasurer Schlottman to serve on the committee. All of these individuals accepted. The committee will bring its recommendations to the 2007 Board meeting. They will also be prepared to propose a person to chair and lead the public relations effort.

In Director Rasmussen's absence, Vice President Elliott gave a publications report. Director Rasmussen is always in need of pictures and articles for the NEWS. Director Kimble stated that he submitted an article on Awards for the Spring 2006 issue and challenged each Board member to submit an article on what their committee is are doing for 10-10.

Treasurer Schlottman reported on the 10-10 Hall of Fame that was discussed at the 2005 Board meeting. In 2005 he had proposed that 10-10 start a Hall of Fame to recognize outstanding members. He is still in the exploratory stages of his research into the subject - contacting other organizations and clubs that have such a recognition program. He asked that this item be deferred until the 2007 Board meeting.

Data Manager Gross reported on the life membership plaque that was approved at the 2005 Board meeting. To date, only one member has requested the plaque. In all, there are approximately 1200 life members that could be eligible for such a plaque. The consensus of the Board was that 10-10 should advertise the plaque's availability for one more year in the NEWS. The need for this program will be re-examined at the 2007 Board meeting. Vice President Elliott gave a report on the QSL Bureau on behalf of Bob Peshka, K7QXG, #5956. Bob and his wife run the bureau. The present backlog of activity is minimal. This is because of poor propagation on 10-meters and the general lack of activity on the 10-meter band. The Bureau was originally funded with \$250.00. Bob still has \$162.50. Bob reports that the bureau has received over 2900 cards and that at present there are over 1400 cards in the unclaimed file. In total the bureau has sent out over 1400 cards. Presently, there are 372 members with cards on file with the bureau. Bob believes that as activity on 10-meters increase, bureau activity will increase. The Board expressed their gratitude to Bob and his wife for all of their work on behalf of the 10-10 QSL Bureau.

Data Manager Gross reported on 10-10's mailing costs. The last U.S. postal increase cost 10-10 an additional \$2,000.00 a year. DX postage has increased also - Canada increased by five cents, Mexico increased by 10 cents and others have increased by up to 15 cents. In January 2007 U.S. postage is expected to increase by another 3 cents. Although these expenses are part of 10-10's operating costs, the increase does impact our organization's

budget. The board discussed an electronic version of the NEWS (.pdf file). While acceptance of this form of the NEWS is increasing, it is still not the preferred method for most members. The Board also suggested the possibility of the Editor adding more color, and even hyperlinks to the electronic NEWS. The feeling was that if the electronic version of the NEWS had enhanced features, possibly more members would elect that version, rather than the paper version. Data Manager Gross will discuss the ideas with the Editor.

#### **New Business:**

Director Moore reported on the 2005 member survey that was conducted through 10-10's website. In all, 89 members replied regarding the general survey and 48 members replied regarding the convention survey. For the general survey 94% of respondents were members, 24% attended the 2005 10-10 convention, 74% of the respondents participate in 10-10's awards programs, 76% of the respondents participate in 10-10's contests, 74% of the respondents are active in 10-10 chapters, 92% of the respondents receive the 10-10 NEWS and 54% of the respondents participate in 10-10's daily nets. Overall, comments were very positive regarding the 10-10 website. Members were especially positive about the new "Breaking News" section of the website. The Board discussed the member comments that were received. Both the pro and con comments were discussed. Each Board member was asked to discuss the comments as they related to their particular committee assignments and 10-10 in general. Board members were pleased with the survey results and believe that many of the ideas generated will help in the operation of their committees. The Board agreed that the website survey is an excellent tool and should be used more in the future. Director Moore agreed to prepare a summary of the survey comments for an upcoming issue of the NEWS.

Vice President Elliott declared a lunch break at 11:57 a.m. Board meeting resumed at 12:33 p.m.

General Counsel Dave Splitt led a discussion related to current 10-10 Bylaws. He also discussed Chapter 3 of the Operations Manual and its relationship to the Bylaws. General Counsel Splitt stated that much of the language in the Bylaws and the Operations Manual is duplicative and in some places contradictory. He suggested that in 2006 the Board address the necessary changes for the Bylaws and Chapter 3 of the Operations Manual only. Then, over the next year the balance of the changes for the Operations Manual could be implemented. The Board agreed with this approach. The General Counsel then led the Board through the proposed Bylaw and Chapter 3 revisions paragraph by paragraph. At the completion of General Counsel's presentation and the Board's discussion, Director Williams made a motion to amend the bylaws in their entirety as presented by the General Counsel. Director Berger seconded the motion. Motion carried. Director Taylor then made a motion to revise the Operations Manual to replace the Bylaws with the revised Bylaws and to amend Chapter 3 as presented by the General Counsel. Director Moore seconded the motion. Motion carried.

Director Ireland discussed the possibility of moving the mobile contest to a later date. He expressed an opinion that a later date would offer better weather conditions and thus more mobile operators. The Board did not have an issue with such a move as long as the new date does not conflict with other major contests. The Contest Committee will explore the possibilities. Director Ireland discussed the CW contest and the perception that it is becoming more of a digital contest. Director Ireland will work with the Editor to place a survey in the NEWS regarding mobile contest dates and the CW contest.

Director Kimble led a discussion on an awards program expansion. Many 10-10 members are requesting a digital award. Over the last year a digital award committee (Director Kimble, Jeff Steinkamp, N7YG, #65084, Bill Heberling, WD5EDR, #23693, and Mel Sojka, KD5DE, #33513) have explored such an award. Director Kimble presented the committee's findings and outlined a suggested award program. He also stated that KD5DE has volunteered to serve as the Digital Award Manager. Director Kimble made a motion to establish a 10-10 Digital Award as presented. Director Williams seconded the motion. Motion carried. Director Kimble volunteered to write an article about the new award program for the NEWS. He also stated that the established committee would continue their work to determine a start date for the award and to finalize rules to be used for the program.

Director Taylor reported on current chapter activities. Currently there are 82 10-10 active chapters. There are another four chapters that are, or will be, going QRT due to inactivity. One chapter has been recently affiliated while an additional chapter has been re-affiliated. Currently one chapter is listed as inactive.

Director Berger led a discussion about WHPW Internet Radio. This is an Internet radio site that has offered 10-10 free advertising and airtime. The Board discussed whether to participate in such a program. Director Berger will explore this further with the new Public Relations Committee and report back to the Board.

Vice President Elliott announced that 10-10 had donated \$100.00 to the Red Cross Hurricane Assistance fund for Hurricane Katrina in 2005.

Director Moore reported on activities for the 10-10 website. The Webmaster is presently testing a new web page design. The new layout will make the site more organized and much easier to navigate. He also reported on tests that were conducted to determine if e-mail links were offering the opportunity for spam. The test results indicate that 10-10's e-mail links do need protection. The Webmaster is working on a solution.

Director Taylor discussed the possibility of using Life Members as Instant Qualifiers for 10-10 membership in DX countries. He said that this had been suggested by a DX member because of the difficulty in making enough contacts for membership during times of low propagation. After much discussion, the consensus of the Board was that this was not something that they would want to pursue.

Treasurer Schlottman presented 10-10 financial report for the

fiscal year ending March 31, 2006. This is the first year that 10-10's total assets have exceeded \$400,000.00. Treasurer Schlottman also reported on IRS filings to continue 501(c)(3) status for the Scholarship Foundation, Dayton Hamvention expenses, and the positive trend of reduced Board meeting costs. Director Williams made a motion to approve the financial report and suggested budget as presented by Treasurer Schlottman. Director Berger seconded the motion. Motion carried.

Director Williams made a motion to approve a write-off of \$5,700.00 for the remaining 10-10 Antenna books that have not been sold. Director Taylor seconded the motion. Motion carried. Data Manager Gross discussed the possibility of having a 10-10 pin prepared that has a date placed on it. 10-10 would sell only a limited number of the pins each year. Because of the date on the pin, it is assumed that the pins would also become collectible. He will look into the costs and report back to the Board.

Having completed the items listed on the agenda and having no further business to conduct, Director Ireland made a motion to adjourn. Director Kimble seconded the motion. Motion carried and the meeting was adjourned at 3:44 p.m.

Vice-President Mike Elliott, K7BOI, called the 2006 10-10 International Net Inc., Scholarship Foundation Board of Directors meeting to order at 3:45 p.m. on June 6, 2006, at the La Quinta Inn in Carter Lake, IA. Present were Vice President Mike Elliott, K7BOI #54625, Secretary Jon Goering, NJ7I, #43483, Director Brad Kimble, K0DBK, #55192, Director Cliff Taylor, K5FBS, #48461, Director Larry Berger, WA2SUH, #407, Director Jack Moore, K5CC, #50708, Director Joe Williams, WA9TSG, #310, and Director Rob Ireland, VE9KM, #69811.

Roll was called by Secretary Goering with all members present except President Chuck Imsande, W6YLJ, #19636, Director Doris Slye, N3TGB, #68129, and Director Steve Rasmussen, N0WY, #68684. These Board members were excused from the meeting either for personal or medical reasons. Invited guests present were Treasurer Keith Schlottman, KR7RK, #63324, General Counsel Dave Splitt, KE3VV, #69831, and Data Manager Gerry Gross, WA6POZ, #21274. A sufficient number of Officers and Directors were present and a quorum was established.

A motion was made by Director Williams and seconded by Director Berger to approve the minutes of 2005 10-10 International Net Inc., Scholarship Foundation Board Meeting. Motion passed.

A motion was made by Director Ireland and seconded by Director Williams to elect the current officers of the 10-10 International Net, Inc., as Board of Directors for the Scholarship Foundation for the years 2005 and 2006. Motion passed. Reports:

Scholarship Manager Larry Berger presented his report and stated the goals for the Scholarship Foundation. 2005 was the best year the Foundation has had to date. A total of \$9,107.00 was given through donations. That is compared to donations in 2005 of \$5,719.00. The dramatic increase was as the result of some large individual donations and one extraordinary donation of \$2,700.00. Typically, there are more donations in the second half of the year than in the first half. There were two donations that were matched by employers. The employer donations totaled \$900.00. Approximately \$800.00 was donated in memory of Bill Marple, AA7ZW, #60275. A large number of donations were also made in the memory of Dick Corlew, NC6V, #25057. Director Berger stated that in the last two years the Scholarship Foundation has sold only about \$25.00 in 10-10 pins and patches. He stated that the Foundation's expenses are minimal. He presented several suggestions on ways to improve donations, some of which have now been implemented. He suggested that 10-10 and the Scholarship Foundation fund six (6) \$1,000.00 scholarships for the upcoming year. His feeling is that members who have made donations would be pleased to see the increase in the number of scholarships funded. Director Berger also reviewed the program that has been established to recognize different levels of donations. Director Berger made a motion to fund six (6) \$1,000.00 scholarships for 2007, and that the scholarship awards again are administered by FAR. Director Williams seconded the motion. Motion carried. The Board did report that FAR's website inaccurately reports that it only awards scholarships to U.S. amateurs. Treasurer Schlottman volunteered to send FAR a letter asking that their website be changed. He will indicate to FAR that the 10-10 Scholarship Foundation is exploring the possibility of awarding a DX only scholarship in the future.

Treasurer Schlottman reported that the only expenses for the Scholarship Foundation are for the scholarships themselves. In 2005 he sent a check to FAR for \$5,000.00. Other Foundation expenses amounted to approximately \$35.00 and were paid by the 10-10 International Net, Inc.

Having completed the items listed on the agenda and having no further business to conduct, Director Williams made a motion to adjourn. Director Taylor seconded the motion. Motion carried and the meeting was adjourned at 4:03 p.m.

## TEN TEN CONTEST RULES

#### 6.2 10-10 OSO PARTIES

10-10 QSO Parties are contests that are held for fun and to meet old, new and prospective members around the world. The rules listed here are for all general QSO parties. The Anniversary and Mobile QSO Parties are specialty contests and do have additional rules.

#### 6.2.1 WHO IS ELIGIBLE?

Contests are open to all amateurs with operating privileges on the 10 meter band, however logs will be accepted only from active members as of the date of the contest. Other logs received will be handled as checklogs. Checklogs are used to validate (check) other logs but do not receive awards.

#### 6.2.2 WHEN ARE THE QSO PARTIES?

There are currently five QSO Parties held through the calendar year:

Winter Phone Contest - held on the first full weekend in February

0001 UTC Saturday through 2359 UTC Sunday.

Spring CW Contest - held on the first full weekend in May

0001 UTC Saturday through 2359 UTC Sunday.

Summer Phone Contest - held on the first full weekend in August

0001 UTC Saturday through 2359 UTC Sunday.

Sprint - a 24 hour contest held on October 10th (10/10)

0001 UTC through 2359 UTC.

Fall CW Contest - held on the last full weekend in October

0001 UTC Saturday through 2359 UTC Sunday.

#### 6.2.3 FREQUENCY AND MODES

Direct unassisted contacts only are permitted. Repeater, Satellite, IRLP or any other similar types of assisted contacts are NOT allowed.

CW Contests should be operated in the CW portion of the 10 meter band and operated using CW and/or any Digital mode (RTTY, PSK, etc).

Phone contests must be operated in the PHONE portion of the 10 meter band and may be operated using any approved Phone method (SSB, FM, AM).

The SPRINT utilizes both CW and Phone portions of the 10 meter band.

## NOTE: A QUIET ZONE between 28.490 and 28.510 shall be in effect during contests using the Phone portion of the 10 meter band to allow for non-contest use of the band. 6.2.4 ENTRY CLASSIFICATION

Entrant may submit a log in ANY of the following classifications:

INDIVIDUAL: includes single station operators and can also include OM/XYL teams or any families or groups of people using individual call signs and 10-10 numbers.

QRP: same as an individual as listed above except that output power does not exceed 5 watts with CW/Digital operations and/or 10 watts with Phone operations during the entire contest.

CLUB: A Club must have a valid club station license issued by their National Licensing Authority. The Club must have active 10-10 membership. Club entries must additionally list the call, name and 10-10 number (if any) for all operators. Operators entering under a club entry may also enter an individual log for contacts made using their own call sign.

#### 6.2.5 TRANSMITTER INFORMATION

An operator may operate mobile, portable or fixed. If they change their exchange QTH during the contest, the operator must show same in their log. The operator may enter a log from only one call district, province, or DX country. Multi-transmitters (two or more transmitters operating simultaneously, sharing one call sign) are NOT permitted in any QSO Party. If a single transmitter becomes inoperable, it is permissible to change to a replacement transmitter.

#### 6.2.6 EXCHANGE

10-10 members send call sign, name, 10-10# and QTH (State, Province or Country). If received exchange does not have a 10-10#, then record a zero[0] in the log.

#### 6.2.7 OSO POINTS

Two (2) points are awarded for contacts WITH a 10-10 number.

One (1) point is awarded for contacts WITHOUT a 10-10 number.

Duplicate entries should be retained in log and show a zero[0] for points.

Any log showing 10% or more errors may be handled as a checklog.

A station may be counted only once regardless of mode.

#### 6.2.8 CHAPTER SCORE ASSIGNMENT

Any entrant who is a chapter member and whose contest operating location is within 150 miles of the primary net location of that chapter, may assign the entrant's score to that chapter. Contest scores for a sprint may not be assigned.

#### 6.2.9 CONTEST ENTRIES

Logs shall be forwarded to the Contest Scorer as identified in the 10-10 NEWS or on the 10-10 web site. It is strongly suggested that logs be sent as soon as possible after the close of the contest. It is also recommended that DX logs should be sent AIR MAIL to insure they are received in good time. Any logs received with a postmark date AFTER the deadline date will be handled as a checklog. Any logs received more than 15 days after the contest entry deadline, regardless of postmark, will be discarded.

#### 6.2.9.1 ENTRY DESCRIPTION

Entries must contain a Cover Sheet, Log, and Dupe Sheet as described here: COVER SHEET will list the Event Entered, Entry Classification, US Call Area (W0-W9) or DX Country, Chapter Score Assignment (if any), number of contacts and points with 10-10#, number of contacts and points without 10-10#, and total contacts and points claimed

LOG must be listed in date/time order and list UTC Date, UTC Time, Call, Name, 10-10# (zero [0] if none), QTH and Contact Point Value.

DUPE SHEET is required for any logs exceeding 50 contacts. It may be either a list of all calls contacted in call sign order, or hand entered on a dupe sheet grid.

#### 6.2.9.3 ENTRY DEADLINE

Entries for all contests listed EXCEPT the Sprint shall be postmarked no later than 15 calendar days (this will always be a Monday) after the close of the contest. Mailed entries for the Sprint (held on 10/10) shall be postmarked no later than October 25th , unless that day falls on a Sunday, then the postmark deadline shall be October 26th.

#### 6.2.10 CONTEST RESULTS AND AWARDS

Contest results will be posted on the 10-10 web site about 15 days after the closing deadline for the contest, and also printed in the 10-10 NEWS in the appropriate issue. Awards will be issued by the certificate manager for Top Ten Individual scorers in the World, the top Individual scorer in each US Call Area (W0-W9) and each DX Country, and for top QRP, CLUB and CHAPTER.

#### 6.2.11 ANNIVERSARY QSO PARTY

This event runs from January 1 0001 UTC to December 31 2359 UTC. Entrants may submit a log of contacts with members that have 10-10's anniversary year contained in their membership number.

Example: 2002 is the 40th anniversary year of 10-10 International Net, Inc. Contact with members containing a "40" in their membership number (i.e., 72040, 69405, 64054, 40126, 00407) would count toward the contest. Each year the anniversary number changes, making a new group of members the focus of the contest and promoting the use of the 10-meter band. All general rules are applicable with the following exceptions:

During the calendar year (January 1 though December 31) make legal 10-10 contacts with 10-10 Number, Date, Call Sign, Name, QTH, with members containing the anniversary year in their membership number as described above.

Contacts must be made on the 10-meter band with any legal mode (AM, SSB, FM, PSK, CW, etc.) but all contacts must be made direct and unassisted. NO repeater, satellite, or Internet assisted contacts are permitted. The contact mode must be recorded in the log entry.

All submitted logs must contain only one entry for each 10-10 number contacted. Contacts MUST be listed in 10-10 number order and each entry must list the 10-10 Number, Date, Call Sign, Name, QTH and Mode, in that order.

This contest is for Individual entries as described in section 6.2.4 and certificates will be awarded for the Top Ten, however all entrants will be listed in the 10-10 NEWS.

Logs shall be forwarded to the Contest Scorer as identified in the 10-10 NEWS or on the 10-10 web site. Logs MUST be postmarked no later than January 15th of the year following the anniversary contest year entered. Only members in good standing (with dues paid) are allowed to submit logs.

#### 6.2.12 MOBILE QSO PARTY

This event is held on the third Saturday in March from 0001 to 2359 UTC. All general rules are applicable with the following exceptions:

Fixed stations contact mobiles, mobiles contact everyone. Mobile applies to vehicular, marine, aeronautical or other mode of transportation. If in doubt, contact the Contest Manager. A station operating a mobile entry must be a true mobile. Sitting in the driveway and using the base station antenna or amplifier, or using commercial power is not permitted. RV generators are permitted only if the generator is used while in transit (moving).

Operation while your vehicle is parked across a county line, occupying two counties, counts as two counties and two contacts. Marine and aeronautical mobiles must be able to establish counties of operation.

The contest exchange shall be Call, Name, State, 10-10 Number (if a member, zero(0) if not), and county (if applicable). Only counties in the USA, Canada and England may be used as a multiplier.

Count one point for each contact whether a member or not. Fixed stations multiply the number of contacts by the number of different counties worked. Mobile stations multiply the number of contacts by the number of different counties worked PLUS a bonus of the number of counties worked from.

All stations must submit separate logs for the counties worked from. Log scores will be combined by the contest manager.

Logs shall be forwarded to the Contest Scorer as identified in the 10-10 NEWS or on the 10-10 web site. Logs MUST be postmarked no later than 14 days after the end of the contest. Only members in good standing (with dues paid) are allowed to submit logs. 6.2.13 FOR MORE INFORMATION

Current information about 10-10 and upcoming 10-10 QSO Parties is always available on the 10-10 web site. Contest cover sheets, logging forms and dupe sheets are also available for downloading or printing. The address is http://www.ten-ten.org

Barbara was very active in 10-10 up until about 4 years ago, when she became ill and had to discontinue a lot of her ham radio activity. I don't know if you ever talked with her, or knew her, she had a Life Membership with 10-10 and was an awards manager in the late 1980's and 1990's. Her picture graced the cover of the 10-10 International News Vol. 18, No.4 for the fall of 1980. Any way, the purpose of this note is to inform you, and the rest of her friends on 10-10, that she passed away on February 10, 2006. So, if you would be so kind as to place her on the SK list in the next 10-10 news publication, I would greatly appreciate it. I am sure there are a number of her contacts out there who are wondering what became of her, since she hasn't been on the radio for some time.

Attached to the back is a picture of Bobbie standing in front of her

"QSL Card Wall". The front of the card is a desert scene with streaks of lightening all over the night time sky.

Bobbie had the phenomenal ability to collect more numbers than anyone and, at the same time, make you think she had all the time in the world to talk just to you. She was the only person I ever knew who seemed to have more than 24 hours in a day. Of course I have the last certificate list she sent me just like I have the last one from everyone else. The ones from the SK are a Hall of Fame of 10-10 - and now Bobbie joins them

When I first started chasing paper I saw a list of Chapters and presumed that the object was to get a certificate from every one. As I got more involved I learned that no one ever had ever done that but Bobbie was closer than anyone. Strangely, Bobbie and I were talking one day about the Chapters we needed to have them all and I only needed one - Tarchang. Someone tried to break us several times but I asked him to wait. When we finally invited him to speak he informed us that he was the Chapter Head of Tarchang and wanted to give me a number, 82FS. I believe Bobbie was happier than I was that I was the first, and probably the only, person ever to hold all active certificates at once.

I return your sentiment on that first QSL Card - Vaya con Dios, Bobbie.



- 3. You must make contact with ten members of 10-10 and submit a log listing all contacts, their 10-10 number, call sign, name, date of contact, and QTH (state/province/country). A new member application and contact log is available in Section 1 on page 31 of this publication.
- 4. You must remit dues for one or more years full membership. Fee schedule and payment information can be found in Section 2 on page 31 of this publication.

## TYPES OF MEMBERSHIPS

#### Primary Membership

Primary membership is available with yearly dues, although there is a special incentive available when you pay for three years at once.

#### Family Membership


